

## **Privacy Policy**

### **Privacy Policy Update**

Dear Reader, Dear User,

we have modified some of our policies to meet the requirements of the new European Regulation for the Protection of Personal Data (GDPR). In particular, we have updated our Privacy Policy and Cookie Policy. Please read the following carefully.

We inform you, pursuant to art. 13 of the European Regulation no. 679/2016, that the Data Controller ex art. 24 of the EU Regulation no. 679/2016 is Centro dell'Uomo (Man Center) - ODV (tax code 91012340468; VAT 02191640511; Postal address: Monastero di Sargiano, 52100 Arezzo (Italy); E-mail: [privacy@centrodelluomo.org](mailto:privacy@centrodelluomo.org); Certified E-mail: [centrouomo@pec.it](mailto:centrouomo@pec.it)) and that the same will proceed to the processing of the data you provided in compliance with the legislation on the protection of personal data processing.

### **Collected data.**

The data collected by us are limited to the so-called common data, namely:

- Buyer identification data, such as: first and last name or company name in the case of companies, telephone number, e-mail address;
- Product delivery data, such as: delivery address (private individuals), delivery address and billing data (companies). It is signaled that the invoice is released only to the companies and not to the private ones.

### **Purpose of data processing.**

The personal data you provide are collected ex art. 6.1.b) Reg. U.E. 679/2016 and, where necessary for the fulfilments imposed by the law, are stored ex art. 6.1.c) Reg. U.E. 679/2016 with telematic modalities and processed, also with the aid of electronic means, for the sole purpose of:

1. Allow the provision of e-commerce service (order submission, order payment, shipping).

The personal information you provide will be stored at Centro dell'Uomo (Man Center) - ODV (tax code 91012340468; VAT 02191640511; Postal address: Monastero di Sargiano, 52100 Arezzo (Italy); E-mail: [privacy@centrodelluomo.org](mailto:privacy@centrodelluomo.org); Certified E-mail: [centrouomo@pec.it](mailto:centrouomo@pec.it)) and processed by any appointed and/or designated, who perform the above activities under Man Center's direct supervision and responsibility.

### **Nature of data provision.**

The provision of the above data is essential in relation to the purpose n.1 for the fulfillment of contractual obligations (art. 6.1.b) Reg. U.E. 679/2016) and the performance of all necessary and functional activities of the Owner, so any refusal will determine the inability to benefit from the services requested.

### **Scope of communication and dissemination of data.**

The data communicated by you may be transmitted to external subjects who carry out functions strictly connected and instrumental to the operativity of the Service (postal service, couriers...).

The transmission of personal data to third countries or non-EU countries is not foreseen, nor the diffusion of the same.

**Data Treatment Duration.**

The data will be treated for the time necessary to carry out the service provided, as well as, for fiscal purposes and fulfillment of legal obligations, according to the regulatory indications in force.

**Rights of Interested People.**

In relation to the aforementioned treatments, you may exercise your rights under Chapter III of EU Regulation No. 679/2016 at Articles 15, 16, 17, 18, 20, 21, 22, which include:

- Obtain confirmation of the existence or not of data concerning you;
- Know the origin of the data, the logic and the purpose on which the treatment is based;
- Obtain access, cancellation, transformation into anonymous form or blocking of data processed in violation of the law, updating, limitation, rectification, revocation, portability and integration of the same data;
- Oppose, for legitimate reasons, the processing of data;
